AS200132 NetOne NL Acceptable Use Policy for IP Transit Service

This Acceptable Use Policy (AUP) outlines the terms and conditions under which NetOne NL ("Provider") provides Internet Protocol (IP) transit services to its customers. By using our IP transit services, customers agree to comply with this AUP. Failure to adhere to this policy may result in suspension or termination of services.

Prohibited Activities

Customers of NetOne NL are prohibited from engaging in the following activities while using our IP transit services:

- a. Pornography: Transmission, hosting, distribution, or storage of any explicit adult content, including but not limited to pornography, is strictly prohibited.
- b. Illegal Activities: Any engagement in illegal activities, including but not limited to the transmission or storage of stolen intellectual property, illegal drugs, or any material that violates applicable laws, is strictly prohibited.
- c. Tor Exit Nodes: Running Tor exit nodes is not allowed. Customers are not permitted to provide network services that anonymize or hide the source of network traffic.
- d. Abuse of Network Resources: Any activities that result in the abuse of network resources, including but not limited to, the execution of network attacks, distribution of malware, or any other activities that may harm the integrity or performance of the network, are strictly prohibited.
- e. Provided IP transit services are for educational purposes and non for profit usage. Bandwidth usage is based on a fair use / acceptable use policy up to discretion of NetOneNL and in good mutual communication on intended use of NetOneNL's services.

Monitoring and Enforcement

NetOne NL reserves the right to monitor and investigate network activity to ensure compliance with this AUP. Customers found in violation of this policy may be subject to immediate suspension or termination of services without prior notice.

Reporting Violations

Customers are encouraged to report any suspected violations of this AUP to NetOne NL promptly. Reports can be submitted to [appropriate contact details].

Changes to the AUP

NetOne NL reserves the right to modify, amend, or update this AUP at any time. Customers will be notified of any changes, and it is the customer's responsibility to regularly review the AUP for compliance.

Any requests for customer information must be in accordance with Dutch law, and NetOne NL will make reasonable efforts to notify the affected customer(s) before disclosing any information unless prohibited by law.
- c. Cooperation with Authorities: NetOne NL may cooperate with Dutch authorities in investigations related to the use of our services, as required by law. However, we will strive to protect customer privacy to the maximum extent permitted by Dutch law.
- d. Data Protection Measures: NetOne NL employs reasonable and industry-standard measures to protect customer data and privacy. Customers are encouraged to review our Privacy Policy for more information on how we handle and safeguard customer information.
